








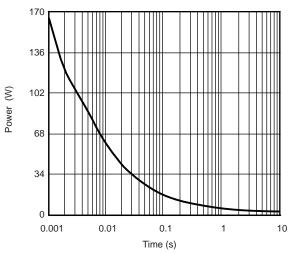
Source-Drain Diode Forward Voltage




Threshold Voltage

Single Pulse Power, Junction-to-Ambient



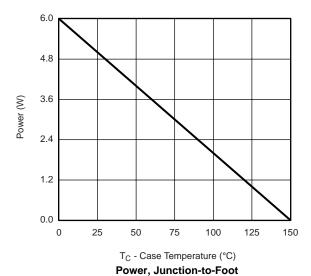




Current Derating*



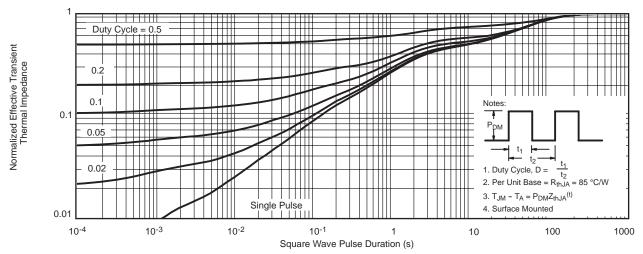



TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



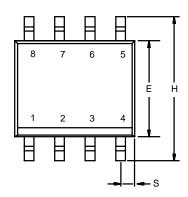
Normalized Thermal Transient Impedance, Junction-to-Ambient
