






Figure 1. On Region Characteristics




Figure 3. Normalized On Resistance vs Junction Temperature




Figure 5. Transfer Characteristics




Figure 2. Normalized On-Resistance vs Drain Current and Gate Voltage




Figure 4. On-Resistance vs Gate to Source Voltage




Figure 6. Source to Drain Diode Forward Voltage vs Source Current




Figure 7. Gate Charge Characteristics




Figure 8. Capacitance vs Drain to Source Voltage




Figure 9. Forward Bias Safe Operating Area




Figure 10. Maximum Continuous Drain Current vs Case Temperature




Figure 11. Single Pulse Maximum Power Dissipation




Figure 12. Junction-to-Ambient Transient Thermal Response Curve




Figure 13. On-Region Characteristics




Figure 15. Normalized On-Resistance vs Junction Temperature




Figure 17. Transfer Characteristics




Figure 14. Normalized on-Resistance vs Drain Current and Gate Voltage




Figure 16. On-Resistance vs Gate to Source Voltage




Figure 18. Source to Drain Diode Forward Voltage vs Source Current




Figure 19. Gate Charge Characteristics




Figure 20. Capacitance vs Drain to Source Voltage




Figure 21. Forward Bias Safe Operating Area




Figure 22. Maximum Continuous Drain Current vs Case Temperature




Figure 22. Single Pulse Maximum Power Dissipation







Figure 23. Junction-to-Ambient Transient Thermal Response Curve


Dimensional Outline and Pad Layout
